## Preface and Acknowledgements

Writing these final pages after years of dedicated work on Tell el-Yahudiyeh Ware vessels brings me immense pleasure. This study has contributed new insights into pottery production in the Levant and shed light on the archaeology and chronology of the Middle Bronze Age in southern Syria.
